The following wastes are allowed for disposal at the transfer station:

- Household garbage, food and other organic wastes **MUST** go inside Transfer Station building into the pit.
- Paints must be dried out/empty before disposal (kitty litter helps dry it out). Place inside Transfer Station building on floor.
- Fluorescent light fixtures and bulbs. (Lamp barrels are provided inside Transfer Station garage for disposal)
- Bins are provided for construction items such as: METAL, FURNITURE, CARDBOARD, and PAPER as well as INERT (which includes items such as wood, drywall, plumbing fixtures, plastic, siding and carpet).
- TV's, computer monitors, and laptop computers. **(A sticker is REQUIRED for disposal of these items and can be purchased at the city administration office prior to disposal.)**
- There is a separate area for residential yard waste outside the fenced area at the Transfer Station. (not intended for commercial use, please ask about the inert landfill for larger quantities.)
- **OUT OF TOWN GARBAGE SERVICE CONTRACTS ARE FOR A YEAR MINIMUM, UNLESS YOU ARE MOVING**

I UNDERSTAND THE ABOVE CHARGES AND MY RESPONSIBILITY OF PAYMENT BY THE DUE DATE, WHICH IS THE 20TH OF EACH MONTH. ***I ALSO UNDERSTAND THAT IF PAYMENT IS NOT MADE BY THE 20TH THAT A PENALTY OF 10% IS ADDED TO THE BALANCE OWED AND THAT SERVICES WILL BE DISCONNECTED AFTER 30 DAYS OF NON-PAYMENT. OVERDUE COLLECTIONS MAY BE ASSESSED TO PROPERTY TAXES.***
